

Description

Thermostatic/thermodynamic steam trap (for banking-up condensate) with adjustable discharge temperature, which discharges condensate from the system without flash steam and at a constant and adjustable discharge temperature.

Design: With corrosion-resistant, water-hammer resistant duo stainless steel Thermovit regulator and Y-type dirt trap with large surface area.

Main application: Steam heat tracing systems.

Fluids

Use in potentially explosive atmospheres

The equipment does not have its own potential source of ignition (as per ATEX Directive). Please note the following:

During operation, avoid excessive surface temperatures caused by the fluid.

The equipment itself does not generate higher surface temperatures.

Once installed, static electricity may arise between the equipment and the connected system. If the equipment is used in potentially explosive atmospheres, the plant manufacturer or owner is responsible for discharging or preventing possible static charge.

If it is possible for fluid to escape, e.g. through actuating mechanisms or leaks in threaded joints, the plant manufacturer or owner must take this into consideration when dividing the area into zones.

Function

The equipment regulates the flow of fluid using a Thermovit regulator. The Thermovit regulator is screwed onto the body. The Thermovit regulator consists of several bimetallic plates stacked on top of one another. As the fluid temperature rises,

these plates expand and cause the nozzle stems to move. The flow orifice closes. When the system is cold, the Thermovit regulator opens.




